Fee regulation for students admitted in Academic Sessions : 2023-24, 2024-25 & 2025-26.

1. The Admission and Fee Regulatory Committee (hereinafter referred to as 'AFRC') constituted under Madhya Pradesh Niji Vyavsayik Shikshan Sanstha (Pravesh Ka Vinyaman Avam Shulk Ka Nirdharan) Adhiniyam, 2007 (hereinafter referred to as 'Act') is empowered to determine fee structure under section 9 of the said Act. Accordingly, it has formulated the policy framework for fee regulation, keeping in view the guiding principles laid down in 'The Madhya Pradesh Niji Vyavsayik Shikshan Sanstha (Pravesh Ka Vinyaman Avam Shulk Ka Nirdharan) Adhiniyam, 2007 and Regulations of Fee 2008 notified on 15 April 2008 & further amendment dated 12.09.2013.
2. As per the advertisement No: 112 dated 14.02.2023, and letter of AFRC secretariat No. OSD/2023/113 dated 14.02.2023, AFRC called for submission of fee proposal for next three year block.
3. The Institute has submitted the information pertaining to regulate fee chargeable from the students of the course B.Ed. for the block of 2023-24, 2024-25 & 2025-26 against the notification issued on 14.02.2023 in this regard.
4. AFRC in its meeting/hearing held on 26.04.2023 discussed in detail with the representative of the society/institute or in absentia. Considering audited accounts for the F.Y. 2020-21/2021-22/2022-23 and with the consent of the society, Committee in its meeting held on 26.04.2023 decided to regulate the fee chargeable from the students by the institute for the sessions 2023-24, 2024-25 & 2025-26 as per the provision 5 (4) of regulations of chargeable fee published on 15th April 2008. This chargeable fee shall be reviewed after three academic sessions i.e. in 2026-27 on submission of audited accounts of FY 2025-26.
5. AFRC allows a reasonable surplus for growth and development fund and for the said purpose institution is required to maintain separate accounts. Institution shall not be allowed to incur revenue expenditure from this fund.

WHEREAS, recognition was granted to the institution, namely, REVA B.Ed.COLLEGE, ADARSH VIDYA MANDIR CAMPUS JAIPRAKASH NAGAR, ADI HARTAL, JABALPUR, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.Ed. (CO-ED) course vide order dated 27-06-2005 for an annual intake of 100 students.

AND WHEREAS, Show cause notice was issued by the WRC to the institution on 28.02.2009 and the reply of Show cause notice was not submitted by the institution.

AND WHEREAS, the refusal order was issued by the WRC on 31.03.2009

AND WHEREAS, appeal filed by the institution u/s 18 of the NCTE Act, 1993 on 28.04.2009. Appeal order dated 18-08-2009, Decision Direction of the Appellate Authority "...the appeal was accepted and WRC's order dated 27.03.2009 was set aside with the direction to the WRC to cause inspection of the new building to ascertain the availability of infrastructure and instructional facilities as per norms and thereafter pass appropriate order."

AND WHEREAS, the matter was placed in 131st meeting of WRC held on February 24-25, 2010 and the Committee decided that "...In compliance of the appeal order dated 18.8.2009, VT be constituted for inspection of the new building of the institution."

AND WHEREAS, the letter was issued by inspection by the WRC to the institution on 28.04.2010 and the inspection conducted on 26-08-2010.

AND WHEREAS, the matter was placed in 140th meeting of WRC held on September 14-15, 2010 and the Committee decided that "...Show Cause Notice be issued to the institution to submit written representation within 30 days before passing the order rejecting the application for permission to shift the premises on the following points:

Building does not exist on the land described in the land documents submitted to WRC.

AND WHEREAS, Show cause notice was issued by the WRC to the institution on 29.09.2010 and the reply of Show cause notice was submitted on 21-10-2010 by the institution.

AND WHEREAS, the matter was placed in 142nd meeting of WRC held on November 22-24, 2010 and the Committee decided that "...Show cause notice regarding shifting of premises not complied with. Therefore, shifting not permitted. The withdrawal of the recognition stands as it is (NCTE/WRC/MP/Legal/APW/0629/223171/2009/R 4104-4109 dated 31.3.2009)."

AND WHEREAS, the withdrawal of recognition stands order was issued to institution on 21-12-2010.

AND WHEREAS, the institution filed W.P. No. 18869/2010, Review P.No.576/2014, & W.P.No.8008/2015, Court order dated 16-06-2015 "...Accordingly, we direct the Regional Director, NCTE, in the first place, to re-examine the matter by inspecting the building and the infrastructure provided in the petitioner college within two weeks from today. The report be submitted by the Regional Director, NCTE not later than 1.7.2015 in this Court, which will be considered on 2.7.2015.

Respondents are also directed to ensure that if the petitioner college succeeds in the present petition, the respondents will be obliged to provide sufficient number of students for being admitted in the petitioner college for pursuing the B.Ed. course for the academic year 2015-16.

Counsel for the respondent/State is relying on the decision of the Supreme Court in the case of Manas Bhawan Devi Mahila Mahavidyalaya Vs. State of Uttar Pradesh and others reported in 2013 (2) SC 617 to contend that if the appropriate Authority submits report in favour of the petitioner, the petitioner college can be treated as recognized only for the following academic year 2016-17.

This submission is completely ill-advised. Inasmuch as, by virtue of order dated 6.8.2014 passed in W.P. No. 18869/2010 in favour of the petitioner passed by this Court, the original recognition granted to the petitioner college stands revived as the de-recognition order has been explicitly set aside. Thus, it will not be a case of fresh recognition but a case of revival of original recognition order.
